\* **EMD shall have to be deposited online (paid online) by all intending tenderers (bidders) and also the Total Application fee (including GST) is to be paid online on the portal for e-procurement: <https://wbtenders.gov.in> .**

\*\* **'Amount' for calculation of EMD (EMD being 2% of 'Amount') shall be as follows:**

- I. For cases of the works in the open tenders costing up to Rs. 62.50 Lakh, the Amount shall be 'estimated value of the work for which tender has been called for' / 'bid value (all inclusive)', whichever is higher.
- II. For cases where the works in the open tenders costing more than Rs. 62.50 Lakh the Amount shall be the estimated value of the work for which tender has been called for.
- III. For special cases with no estimated value due to relatively small value of the work for which tender has been called, the Amount shall be 'bid value (all inclusive)'.
