### NOTIFICATION

In modification of the provisions laid down in Clause 8(i) of the order No. Infra/Gen/2P-25/10/718 Dated 16/08/2011, the policy of the Corporation regarding permission for Change in Product/ Product line will be the following.

- (a) If any allottee company or firm in any Industrial Park of the Corporation or in any other land allotted by WBIIDC applies for change of only the product line which does not require any major overhauling of existing plant infrastructure, permission may be granted without consideration of any fee. Only the allottee may be asked to clear the outstanding dues of the Corporation, if any, after which the necessary permission may be granted. However, the product line so proposed must be of industrial nature.
- (b) If any allottee company or firm in an Industrial Park of the Corporation or in any other land allotted by WBIIDC applies for a change in the nature of product requiring a major change in infrastructure of plants and machineries, the allottee is to submit a DPR along with the application to the Corporation. The allottee may thereafter be allowed to proceed with their new product, after clearing the outstanding dues of the Corporation, if any, and the permission may be granted without consideration of any fees. In this case also, the product line so proposed must of industrial nature.
- (c) The timeframe to accord the approval of the Product/ Product Line Change for industrial units would have to be done within 3 (three) weeks from the date of receipt at WBIIDC's Office. After expiry of the 3 (three) weeks time of receipt of such application and if no further communication is made by the Corporation, it would be deemed as the permission is accorded.
- (d) The clearance of outstanding dues to the Corporation would also include the clearance of outstanding dues to the Association of the Entrepreneurs to which the Operations and Maintenance of the Industrial Park has been handed over by the Corporation.
